The table below shows the five categories of enquiries we have, and shows what our current target for dealing with each category is, and then what we are proposing to change the target to.

| Priority | Type of Enquiry | Current Target | Proposed Target |
|----------------------------|---|-----------------------|-----------------|
| Public Safety A+ Enquiries | Imminent danger to the public | 2 Working Days | No change |
| Priority A Enquiries | Safety related issues that are not a Public Right of Way core function e.g. district / police / landowner function | 10 Working Days | 4 Weeks |
| Priority B Enquiries | Obstruction and encroachment Drainage Ploughing and cropping Structures in disrepair | 14 Weeks | 26 Weeks |
| Priority C Enquiries | Request for barriers Waymarking of paths Surface repair inspections | 28 Weeks | 36 Weeks |
| Priority D Enquiries | Surveys Defective fencing Unauthorised signs | When resources permit | No change |
